# ADDENDUM

## AGREEMENT FOR THE FOUNDATION OF THE INTERNATIONAL CENTRE FOR STUDIES AND RESEARCH (ICSR) “MEDITERRANEAN KNOWLEDGE”

(Inter-University Centre according to the article 41 of the Statute of the University of Salerno)

### BETWEEN

Università degli Studi di Salerno (University of Salerno), with office and fiscal domicile in Fisciano (Salerno, Italy) 84048, Via Giovanni Paolo II 132, Fiscal Code 80018670655, represented by the Rector prof. Aurelio Tommasetti;

### IT IS HEREBY AGREED AS FOLLOWS:

- a) Among the cited above Universities, Research Centres and other Public and Private Bodies, represented by the Rectors and/or by their legal representatives, it's formalized the accession to the International Centre for Studies and Research (ICSR) “Mediterranean Knowledge”, in accordance with the art. 12 of the Constituent agreement.
- b) The accession is regulated by the following articles which, in their entirety, constitute its own rules.

#### Art. 1 - Accession

The accession, after the approval of the Rector's Decree of establishment and of the entire text of the Agreement by the competent bodies of the applicant university/research centre, is submitted to the approval of the Executive Board, after formal request presented to the Director of the International Centre for Studies and Research (ICSR) “Mediterranean Knowledge”, in accordance with the art. 12 of the Constituent Agreement.

The application is formalized by the signature of the present addendum to the Constituent Agreement of the ICSR.

The Rector's Decree n. 2236 of 26<sup>th</sup> May 2015, which establishes the ICSR and the entire text of the Agreement, composed by 18 articles, are enclosed in both Italian and English version to the present addendum, in order to be an integral part.

#### Art. 2 - Research Unit

In order to carry out its statutory activities, the ICSR is organized in Research Units composed by scholars active in the ICSR areas of competence, in accordance with the art. 4 of the Constituent Agreement.

The composition of the Research Unit – at least two scholars – is communicated by letter of the Rector/Director/Legal Representative of the applicant body.

### **Art. 3 - Duration and Termination**

The present addendum to the Constituent Agreement of the ICSR enters into force on the date of signature by the Rector of the University of Salerno and has the same duration of the Agreement.

Each University, Research or Higher Education Institute and any public or private body has the right to withdraw, by sending a formal cancellation the Director of the ICSR at least three months before the expiration.

Upon expiry of the Agreement, it will be renewed by written agreement among the parties, approved by the competent bodies.
